The NLN Foundation for Nursing Education will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information.

The NLN Foundation for Nursing Education will store all the personal information you provide on its secure servers.

Information relating to electronic transactions entered into via the NLN Foundation for Nursing Education website will be protected by encryption technology.

Cross-border Data Transfers

Information that the NLN Foundation for Nursing Education collects may be stored and processed in and transferred between any of the countries in which the NLN Foundation for Nursing Education operates to enable the use of the information in accordance with this privacy policy.
